Such a player may only have his J1 Sanction approved once his team has been eliminated from the Senior Inter-County Championship (including All-Ireland qualifier games).

### \* B \* RIALACHA | RULES

- 1) All players are required to familiarise themselves with the relevant sections dealing with sanctions in USGAA Regulations 3 and 4 (located here <http://bit.ly/2nG373K>) and Rule 6.12 of the Official Guide.
- 2) Any sanctioned player who travels to Ireland, and wishes to return to the US and resume playing GAA, must first have the written approval of USGAA prior to travelling to Ireland. USGAA Regulation 3(c)
- 3) Requests for Sanctions must be accompanied by receipt of appropriate travel insurance cover. Please note that this is not private health insurance. See <http://www.gaa.ie/the-gaa/rules-regulations/overseas-sanctions>
- 4) Sanctions are only available to current members of Clubs in Ireland.
- 5) A player who has received a Sanction shall not be eligible to play again with his Club in Ireland for the 30 days after the date of approval of his Sanction by Central Council.
- 6) Once approved, a Sanction shall entitle a player to play with a Club in the North American County Board area from March 1 to October 31 in any given year. A Sanction will not be granted after July 1<sup>st</sup>.
- 7) All correspondence with Central Council must come through your County Secretary.
